#### Excellency

I have the honour to refer to discussions between the Government of the United Kingdom of Great Britain and Northern Ireland (hereinafter referred to as the Government of the United Kingdom) and the Government of the Hashemite Kingdom of Jordan (hereinafter referred to as the Government of Jordan) under the terms of the Agreed Minute on the consolidation of the debt of the Government of Jordan signed in Paris on 28 February 1992 (hereinafter referred to as the 1992 Consolidation) concerning the Exchanges of Notes (EON) constituting the loans listed as follows:

- (a) the United Kingdom/Jordan Development Loan 1966/67, (EON signed at Amman and dated 25 and 26 July 1966);<sup>2</sup>

- (t) the United Kingdom/Jordan Construction Work/Arab Potash Company Loan 1979, (EON signed at Amman and dated 14 March 1979);<sup>1</sup>
- (u) the United Kingdom/Jordan Amman Electricity Project Loan 1980, (EON signed at Amman and dated 4 November 1980);<sup>2</sup>
- (v) the United Kingdom/Jordan Loan 1982, (EON signed at Amman and dated 14 March 1982);<sup>3</sup>
- (w) the United Kingdom/Jordan Loan 1987 No. 1, (EON signed at Amman and dated 1 October 1987);<sup>4</sup> hereinafter together referred to as "the aid loans".

In accordance with the 1992 Consolidation the repayment schedules of the aid loans in respect of those repayments of interest and principal due as at 31 December 1991 inclusive, and not paid, and those repayments of principal and interest due between 1 January 1992 and 30 June 1993 inclusive, shall be revised.

Amounts equal to 100 per cent of the principal and 50 per cent of the interest due as at 31 December 1991 inclusive, which remain unpaid, and 100 per cent of the principal and interest due between 1 January 1992 and 30 June 1993, inclusive (hereinafter together referred to as "the rescheduled amounts") shall be paid by the Government of Jordan in pounds sterling in London to the Government of the United Kingdom in twenty (20) equal and successive semi-annual payments, the first payment to be made on 31 March 2001 and the final payment to be made on 30 September 2010.

The sums to be paid in accordance with paragraph 3 above are specified in Table A of the Annex to this Note.

No interest shall be charged on the rescheduled amounts as specified in paragraph 3 above and Table A of the Annex to this Note.

In all other respects the terms and conditions of the aid loans shall continue in force. In particular, interest payments due under the terms of the aid loans shall be calculated as if repayments of principal falling due up to and including 30 June 1993 had been paid in full.

If the terms and conditions set out above are acceptable to the Government of Jordan I have the honour to propose that this Note, together with its Annex and your reply to that effect, shall constitute an Agreement between our two Governments in this matter which shall enter into force on the date of your reply and shall be referred to as the United Kingdom/Jordan Debt Rescheduling Agreement 1992.
