EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT BE-TWEEN THE GOVERNMENT OF THE FRENCH REPUBLIC AND THE GOVERNMENT OF THE RUSSIAN FEDERATION CONCERNING THE METHODS OF APPLICATION OF THE AGREEMENTS ON ARCHIVES

Paris, 12 November 1992

Sir.

With reference to the Agreement between the Government of the French Republic and the Government of the Russian Federation on cooperation between the Government of the French Republic and the Government of the Russian Federation relating to public archives, of 12 November 1992,² and the Agreement between the Government of the French Republic and the Government of the Russian Federation on the search for archive documents and their restitution, of 12 November 1992,³ I have the honour to propose the following arrangement concerning the procedure for the restitution of French archive documents transported out of France during the Second World War.

(1) Preparation for the phased repatriation of all French archive documents shall begin as of November 1992. This preparation shall include, *inter alia*, the transmission to the French authorities of all inventories in the form of copies made at the expense of the French Party.

The full repatriation of the French archive documents shall be completed by 31 December 1993 at the latest.

(2) The French Party undertakes, within the limits of budgetary allocations, to microfilm, at its own expense, documents of interest to Russia identified by Russian experts with the participation of French experts. The final list of these documents shall be determined by joint agreement.

The microfilming operations shall be completed by 31 December 1994 at the latest.

(3) The timetable for the phased restitution of the archive documents and the transmission of microfilms, and also other technical questions, shall be agreed upon by the archive institutions of the two Parties during the first quarter of 1993.
