MEMORANDUM OF UNDERSTANDING¹ BETWEEN THE UNITED NATIONS AND THE GOVERNMENT OF THE REPUBLIC OF URUGUAY CONCERNING CONTRIBUTIONS TO THE UNITED NATIONS STANDBY ARRANGEMENTS SYSTEM

RECOGNIZING THE NEED TO EXPEDITE THE PROVISION OF CERTAIN RESOURCES TO THE UNITED NATIONS IN ORDER TO EFFECTIVELY IMPLEMENT IN A TIMELY MANNER, THE MANDATE OF THE UNITED NATIONS PEACEKEEPING OPERATIONS AUTHORIZED BY THE SECURITY COUNCIL,

FURTHER RECOGNIZING THAT THE ADVANTAGES OF PLEDGING RESOURCES FOR PEACEKEEPING OPERATIONS CONTRIBUTES TO ENHANCING FLEXIBILITY AND LOW COSTS,

HAVE REACHED THE FOLLOWING UNDERSTANDING:

I. PURPOSE

THE PURPOSE OF THE PRESENT MEMORANDUM OF UNDERSTANDING IS TO IDENTIFY THE RESOURCES WHICH THE GOVERNMENT OF THE REPUBLIC OF URUGUAY HAS INDICATED THAT IT WILL PROVIDE TO THE UNITED NATIONS FOR USE IN PEACEKEEPING OPERATIONS UNDER THE SPECIFIED CONDITIONS.

II. DESCRIPTION OF RESOURCES

1. THE DETAILED DESCRIPTION OF THE RESOURCES TO BE PROVIDED BY THE GOVERNMENT OF THE REPUBLIC OF URUGUAY IS SET OUT IN THE ANNEX TO THE PRESENT MEMORANDUM OF UNDERSTANDING.

2. IN THE PREPARATION OF THE ANNEX, THE GOVERNMENT OF THE REPUBLIC OF URUGUAY AND THE UNITED NATIONS HAVE FOLLOWED THE GUIDELINES FOR THE PROVISION OF RESOURCES FOR UNITED NATIONS PEACEKEEPING OPERATIONS.

III. CONDITION OF PROVISION

THE FINAL DECISION WHETHER TO ACTUALLY DEPLOY THE RESOURCES BY THE GOVERNMENT OF THE REPUBLIC OF URUGUAY TO ANY PEACEKEEPING OPERATION REMAINS A URUGUAYAN DECISION IN ACCORDANCE WITH NATIONAL NORMS.

IV. ENTRY INTO FORCE

THE PRESENT MEMORANDUM OF UNDERSTANDING SHALL ENTER INTO FORCE ON THE DATE OF ITS SIGNATURE.

V. MODIFICATION

THE PRESENT MEMORANDUM OF UNDERSTANDING, INCLUDING THE ANNEX, MAY BE MODIFIED AT ANY TIME BY THE PARTIES THROUGH EXCHANGE OF LETTERS.

VI. LANGUAGE


THE PRESENT MEMORANDUM OF UNDERSTANDING IS ESTABLISHED IN TWO ORIGINALS, IN THE ENGLISH AND SPANISH LANGUAGES, BOTH TEXTS BEING EQUALLY AUTHENTIC.

VII. TERMINATION

THE PRESENT MEMORANDUM OF UNDERSTANDING MAY BE TERMINATED AT ANY TIME BY EITHER PARTY, SUBJECT TO A PERIOD OF NOTIFICATION OF NOT LESS THAN THREE MONTHS TO THE OTHER PARTY.
