[ENGLISH TEXT – TEXTE ANGLAIS]

The Government of the Republic of Cyprus and the Government of the Republic of Uganda, hereinafter referred to as "the Parties",

desirous to broaden further the friendly relations between the two countries on the basis of equality and for their mutual benefit, and recognising the importance of Tourism for the development of their economic relations,

have agreed as follows:

Article 1

The Parties particularly wish to establish and broaden the tourist relations between their respective countries, for the purpose of improving the mutual knowledge of life, history and culture of their people as well as for the purpose of increasing their bilateral exchanges in the economic field.

Article 2

The Parties shall, subject to their laws and regulations in force, simplify travelling formalities for the purpose of establishing and increasing the tourism traffic between their respective countries.

Article 3

The Parties shall give special attention to the establishment and increase of tourism between their respective countries, namely organised and individual tourism, thematic specialised travel groups such as congresses, symposia, exhibitions, sport activities, music and theatre festivals.

Article 4

The Parties are in favour of a closer cooperation between their administrative authorities and tourism organisations as well as between other organisations participating in the development of tourism.

Article 5

The Parties shall consider with favour the exchange of tourist information, in order to promote the tourist industry, namely by means of publicity, information and advertising, exchange of printed material, films and expositions.

Article 6

The Parties shall encourage their nationals to:

undertake training courses or studies in the field of hotel and tourist management

- enter agreements between tourist organisations, particularly those concerned with the implementation of tourist development studies and projects.
- invest in the management and operation of hotels and other tourist enterpises in Uganda.

Article 7

The Parties shall take appropriate measures to promote further cooperation between their respective Tourist Administrative Authorities to hasten dissemination and exchange of information concerning their achievements.

Article 8

The Parties shall facilitate exchange of information, experience, literary and artistic documentation, books, pamphlets and magazines concerning tourism.

Article 9

Each Party may request, in writing the revision or amendment of all or part of the provisions of this Agreement. Any revisions or amendments of this Agreement shall enter into force upon notification of their approval by the two Parties.

Article 10

For the follow up of the implementation of this Agreement, promotion and evaluation of the results of the same the Parties will form a Working Group.

The Working Group will meet alternatively in Cyprus and Uganda, with the frequency to be decided by itself, with the aim of evaluating the activities carried out on the basis of this Agreement, and recommending measures for enhancing cooperation between the Parties.

Article 11

This Agreement is concluded for a period of five years and may be renewed by tacit agreement for further periods of one year each unless either of the parties expresses its intention to terminate it by a written notification to the other through diplomatic channels three months in advance of the date of expiring.

The termination of this Agreement shall not affect the implementation of all commitments undertaken during its validity which shall be implemented in accordance with the terms of the present Agreement until their conclusion.

Article 12

This Agreement shall enter into force on the date on which both Parties notify each other, through diplomatic channels, of the completion of the procedures provided by their national legislation.
